Coastal Infant Aquatics, LLC Policies and FAQs

Tuition: The six week session payment is due prior to beginning lessons and at least half must be paid inadvance to hold your time slot. Payments: All payments are to be made by either Zelle or cash. Please use my business email (coastalinfantaquatics@gmail.com) or my cell number for Zelle. If you do not have Zelle I will accept Venmo please email me to request my account information. If your payment is declined, I will contact you. Tuition must be paid immediately or you will forfeit your space in lessons. Lessons are \$180 per week as well as a \$50 registration fee. The total amount due prior to the start of lessons is \$1,130 plus the registration fee for new families. This payment also secures your lesson time and start date.

Dates Closed/ Weather Cancellations: Memorial Day, July 4th & Labor Day. Please contact us to discuss other religious holidays. We swim even if it's raining. We will cancel if there is thunder/lighting. You will be personally contacted if class is canceled. Refunds / Make-ups: We do not offer make-up lessons or give refunds. In the event you register your child and an emergency comes up you can switch your child's session (one-time change only) to another session. If your child is sick please let me know as soon as possible.

Goggles: Only if they always wear goggles and are very comfortable with them already. Otherwise, no goggles please.

Can My Child Eat Before Class?: No. Do not feed your child for 2 hours prior to their lessons. Water Only. 4 hours prior to lessons carbs only. Ex: waffle, plain pancake, quaker oatmeal (not organic), Cheerios, toast. Also breast milk and rice milk is fine. Carbs Only, no fruit, meat or dairy. Undigested food in child's stomach will come up in the pool if your child burp's and we cannot have kiddos throwing up food in the pool. It also makes most children upset; they think they are sick. Once your child is swimming and has great breath control we can lighten up on the "Jail house" food rule.

What If My Child Is Crying?: Most children will cry. Children cry for different reasons. First, they are in a new environment with a new person. Second, they are learning a completely new skill. Once your child learns their new skill and gains confidence they will stop crying. We will all work together on getting past this phase and making your children as happy as can be while becoming safe in the water.

What Does My Child Wear?: All Children (6 months - 4 years old) MUST wear a Swim Nappy reusable swim diaper. One diaper per child is included in your registration fee. Disposable swim diapers (Little Swimmers) do not hold in fecal matter. It actually seeps out the sides which is why the stool looks a bit runny when you change your child out of it. (YUCK!) Accidents in the pool can be dangerous and are very costly. To ensure the safety of your child, all children under the age of 4 must wear a Swim Nappy swim diaper. If you would like more than one diaper, you can purchase an extra for \$20. The diaper must fit very snug around the waist and the legs. Swim nappies will not leave marks on your child. They're made of soft neoprene material and are Fecal Proof when worn properly.

Driving Rules in Neighborhood: Please keep in mind that lessons are in a residential area. To ensure the happiness of the neighborhood and the safety of the people who reside here please remember the speed limit is 20 MPH!!!! We always want to set the best example to our neighbors and keep our children safe. If you do not obey the 20 mph speed limit and neighbors/parents or the HOA complain; I will not be able to continue to teach your child in my program.

Supervision: Parents / caregivers must remain at the pool with their child
the entire time of their lesson. Parents/caregivers are responsible for
watching all children accompanying them to lessons, at all times.

Bathroom: Please do your best in making sure your little one has used the restroom before arriving to class. There will be no restroom available while at lessons since most host families are working from home and require minimal disruptions. I would greatly appreciate that you treat our host family's house the way you treat your own home.
